2.0 DISCUSS TECHNOLOGY PLAN

2.01 Information Update On 1:1 Inservice Attended By Some Committee Members

- Steve Lutzke distributed a memo written by Ann Buehl summarizing the 1:1 inservice she attended at CESA 2. The committee reviewed the summary and discussed different aspects of the report
- Steve Lutzke shared information about Wheatland J1 School District's journey to a 1:1 environment. Wheatland is a 5K-8th grade district and provides 1:1 in grades 4-8. They have seen many positive results including better student performance, increased school pride from parents and students as well as a +409,500 change in open enrollment revenue.

2.02 Review/Revise Draft Action Plan

- Each committee member received a draft copy of the 1:1 action plan for review. Jan Bleicher expressed concern that he had unanswered questions regarding the type of device that would be used in this plan, which groups would receive the device and the costs associated with the plan. Karen Strandt-Conroy shared that she felt that it was necessary to move forward with the 1:1 initiative right away and some of the specific details would evolve as we implement the plan. Steve Lutzke shared that Ben Irwin had identified approximately \$100,000 in the budget that could be reallocated to the 1:1 initiative and that leasing the equipment may prove to be a more affordable way to finance the project. Steve Lutzke also shared that the project may cost in the range of \$250,000. Lutzke stated that his suggestion was to implement the program with 7th grade and work upward. His hope would be to provide a Ipad to all teachers and support staff and 7th and 8th grade students for the 2013-14 school year. Lutzke stated that at the January meeting solid numbers would be provided to show the cost of the implementation.

2.03 Prepare Recommendation For The Board

- Steve Lutzke shared that it was necessary to identify the cost of the project and then develop a specific marketing message for the board to support the approval of the project. The marketing component of the action plan was discussed and the committee decided that having input from business, agriculture, senior citizens, teachers, parents and students would help in expressing the urgency of this initiative.
