Parkview Blog - Inclement Weather Decisions 2024

November is now here and the first snows have fallen in northern Wisconsin, so a snowstorm is possible at any time. Daylight savings time ended this past Sunday, so the days are getting shorter and it is a certainty that the weather will start getting colder. I have also received notice from the National Weather Service that we will be having our first informational meeting for the school year about their warning procedures for the any future inclement weather forecasts. So, I thought that this would be an appropriate time to write a blog about how I make decisions about whether or not to close school because of inclement weather.

There is no magic formula for when school will be delayed, let out early or closed. The decision is based upon whether or not our school busses can safely complete their routes and get the children safely to school. In order to make this determination, I receive weather updates from the national weather service, talk with my fellow superintendents from around the area and most importantly communicate with Kobussen, our bus company about what they are experiencing and their thoughts about whether or not they believe they can safely do their bus routes. If it appears that road conditions are treacherous and not likely to improve then school is canceled for the day. I start working on this decision between 4:00 a.m. and 5:00 a.m. and I try to make decision before 6:00 a.m. Once the decision has been made, a mass message will be sent out to all staff and parents, I will then contact the various radio and television stations to inform them about my decision and the decision will be placed on our website and Facebook page. I will also call the administrative team, maintenance and food service staff to let them know about my decision, so that they can appropriately plan their day.

When the weather becomes extremely cold, schools make their decisions to close based upon the wind chill temperature. In the past, it has been my experience that when a winter weather warning is issued by the National Weather Service, school will be cancelled. The wind chill temperature that triggers this extreme cold watch/warning is a wind chill of negative 30 degrees below zero. This is a change from last school year when the wind chill warning was set at 35 degrees below zero. However, if weather central issues a wind chill advisory then I will determine what I believe is in the best interests of the staff, students and parents of the school district based upon local conditions. The national weather service has now changed its weather language to the following:

- Extreme Cold Watch/Warning will now be -30F wind chill (was -35F)
- Cold Weather Advisory is -20F wind chill no change
- Wind Chill Watch becomes Extreme Cold Watch
- Wind Chill Warning becomes Extreme Cold Warning
- Wind Chill Advisory becomes Cold Weather Advisory

The decision to call off school is definitely not an exact science. I will make the decision based upon the best information that I have available at the time. If I determine that conditions exist that will allow school to run on schedule and you disagree with my decision, please feel free to keep your child or children at home. As a parent, you will need to make the decision that you feel is best for your family and I will always respect your decision.

Finally, people sometimes wonder whether or not inclement weather days will be made up in the summer. The current language about inclement weather days is that the first two days will not be made up by the students and the staff and any days after the first two days will be made up at the discretion of the District. When determining if any additional days can be waived, I look at whether or not the school district will meet the minimum numbers of face-to-face hours required by the Department of Public Instruction, which is approximately the equivalent of 175 days.
