1.0 MEETING CALLED TO ORDER - Meeting called to order at 4:59 p.m.

2.0 CLOSED SESSION

The School Board will adjourn into closed session under State Statutes 19.85(1) (e) to discuss contract negotiation strategy with employee unions.

Motion by Elizabeth Brockwell, second by Bill Wingerson to adjourn into closed session at 5:00 p.m. Roll Call Valley – Yes; Brockwell – Yes; Wingerson – Yes; Motion carried 3-0.

The committee discussed various proposals related to base wage negotiations for the 2013-2014 school year.

5.0 DISCUSS CERTIFIED BARGAINING PROPOSALS

Mr. Lutzke started by reviewing the current state of negotiations regarding Act 10 and the current Consumer Price Index, which is at 2.07%. Next, Mr. Lutzke presented the proposal of a \$750 increase to every teacher's 2012-2013 base salary. Mr. Lutzke also stated that the increase was the maximum that the District could offer to be in compliance with Act 10.

The group next moved into a discussion on the financial impact for staff from the health insurance changes. Mr. Schullo shared with the group his thoughts on the impact of Act 10 and then asked for feedback from the board members present.

Next, the group had a discussion on the salary structure of teachers and how it has changed over the years.

Mrs. Fox stated that she did not agree with the position of the District to begin negotiations with the legality of Act 10 still undecided.
