

## GRADING SYSTEMS

The Parkview School District shall evaluate student achievement in grades PreK through 12. The issuance of grades on a regular basis serves to:

- a. Promote a process of continuous evaluation of student performance.
- b. Inform the student and his/her parent(s) or guardian of the student's progress.
- c. Provide a basis for bringing about change in student performance if such change is deemed necessary.

### Determination of Grade Point Average

1. All classes taken by a student will appear on the official high school transcript. All classes taken for a grade will be included in the GPA.
2. An audited class will be recorded on the official high school transcript but will not earn credit and will not be figured in the GPA. A class taken for Pass-Fail will be recorded on the official high school transcript, and will earn credit. A class taken for Pass-Fail will not be figured into the GPA. Auditing a class or taking a class for Pass-Fail must be approved, in advance, by the principal.
3. A student that receives a grade of less than a "C" may re-take the course.
  - a. Any course of less than a "C" that is re-taken; the newly earned grade will replace the previous grade. No additional credit will be granted for retaking a previously passed course.
4. Transfer credits
  - a. Students transferring from other public school systems, private schools, foreign schools or home-based private educational programs shall be required to provide a transcript or other record of academic accomplishments including attendance information, level of academic achievement, subjects completed, credits earned and standardized achievement test record. Credits earned at an alternative/home school will count towards graduation but will not be figured into a student's academic GPA.
  - b. If academic transfer records are not available or do not contain appropriate information upon which to make placement decisions, the student shall be administered nationally standardized achievement tests and/or district-developed criterion-referenced tests.
  - c. Grades earned in a foreign country by a student with permanent residence status, will be matched to similar classes at Parkview School District as closely as possible. Credits will count toward graduation, but not towards the students' academic GPA.
  - d. Credits earned abroad will be awarded Pass-Fail credit but will not be figured into the student's academic GPA.
  - e. A student's grade will consist of an adequate number of tests, quizzes, projects, daily assignments and homework. The grades are unweighted and letter grades will be assigned the GPA point value listed below.

The District Grading Scale is as follows:
