To qualify for consideration for early admission into kindergarten or first grade, ALL of the following criteria must be met ("Yes" indicates the child has met that criteria, "No" indicates the child has not met the criteria).

1. \_\_\_\_\_ Child turns five/six after September 1, but before December 31 of the school year they expect to enroll.
  
2. \_\_\_\_\_ Written request for early admission as well as a complete early admission questionnaire (Exhibit B) has been made to the building principal prior to April 1.
  
3. \_\_\_\_\_ A personal interview involving the child's parent(s)/guardian has been held with the principal and school psychologist to discuss the reasons for requesting admission and the criteria used to make decision (Exhibit C).
  
4. \_\_\_\_\_ An assessment is conducted by the school psychologist and a kindergarten/first grade teacher, to determine the child's aptitude to learn (intelligence) and their level of academic readiness. The child will be expected to work alone with the examiner.
  - a. \_\_\_\_\_ The child demonstrates exceptional skills on a formal/informal screening measure of school readiness and academic skills.
  
  - b. \_\_\_\_\_ The child, having met the criteria for "a" above, also scores at or above the 90 percentile on the latest edition of a standardized intelligence or cognitive abilities test.

5. \_\_\_\_\_ An admissions team, made up of the principal, school psychologist, and a kindergarten/first grade teacher, has reviewed the above information and supports early entrance into kindergarten/first grade for a trial period of four weeks, after which the team will reconvene and make a final decision as to continuation or termination of the placement.

\_\_\_\_\_ Child recommended for a four-week trial admission.

\_\_\_\_\_ Child NOT recommended for early admission.
